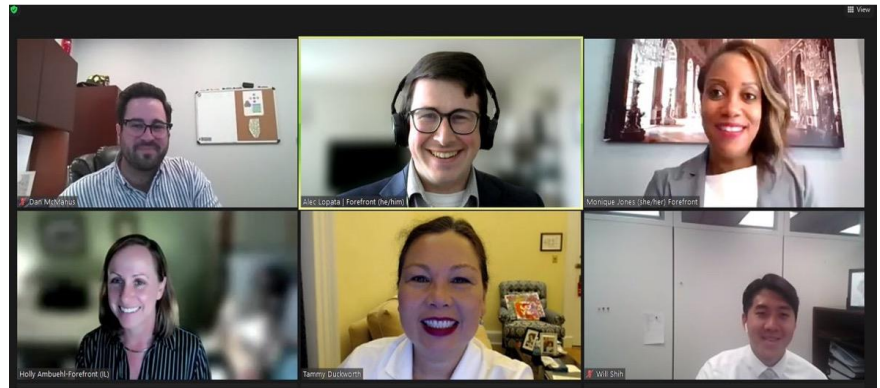

GATA 101



Illinois Heavily Relies on Grants for Service and Program Delivery

- Grants help build and repair our statewide roads and infrastructure
- Grant agreements with community-based organizations, not-for-profits and others carry out services and programs on behalf of the State of Illinois
 - Grantees deliver essential services to the most vulnerable citizens including the development of children
 - Grantees provide training and skill development to those entering or adapting to the workforce

Illinois' program and services success is directly related to the success of its grantees



Illinois Receives and Awards a Significant Amount of Grant Funding

- Illinois spends approximately \$26.6B in federal financial assistance annually – in FY21, \$62.4B was spent due to increased federal Coronavirus funding
- Illinois distributes approximately \$15.8B in state-issued award agreements between state agencies and grantees
- Approximately \$12B of the state-issued awards are used for match or maintenance of effort required by federal funding
- Capital funding substantially increased the number and amount of grants awarded
 - Capital Budget: FY22 enacted \$18.7B; FY23 enacted \$19.1B (lines 4400 and 4900 – all grants)



Drivers of GATA Legislation

- Human service grantees demanded consistent, federally compliant requirements for all grants – regardless of funding source or organization type - to simplify processes and remove redundancies
- Simultaneously, publicized grant fraud (NRI) and inadequate oversight of public funds drove the enactment of GATA legislation
- GATA became law under Gov. Quinn (2014 30 ILSC 708); sunset removed in 2018 (PA 100-0676)
 - Federal Uniform Guidance, 2 CFR 200, also went into effective 2014
 - Timing leads to perception that GATA established current grant rules
- GATA adopts federal requirements for all state-issued awards driving transparency and accountability for all public funds



State Grants and State Grant Making Agencies

- “State-issued awards” - financial assistance awarded by a state grant making agency using state, federal pass-through or a combination of these sources of funding
- Nearly 95% of all grant funds expended are administered by 8 grant making agencies – GATA Advisory Agencies
 - DCEO, DHS, DPH, ISBE, IDOT, DCFS, Aging and ICCB
 - Illinois’ Catalog of State Financial Assistance (CSFA) includes more than 2,500 programs and nearly 47,000 awards to more than 9,200 grantees
 - 47% of grantees receive grants from multiple state agencies



Grant Making Process

Grant Accountability and Transparency Act (30 ILCS 708)

GATA strengthens Illinois' grant making programs, following the guidance of 2 CFR 200, through a uniform process and templates for:

1. Registration
2. Pre-award Process
3. Award Process
4. Post-award Process



Grant Life Cycle

- GATA frameworks give grantees and state agencies a roadmap for using grant funds.
 - Grantees follow same requirements for all funding - subject to funding terms
- Grantees provide information once and it's shared with state agencies: Pre-Award qualified status and ICQ, Post-Award and Closeout in GATA's audit system, ARRMS.

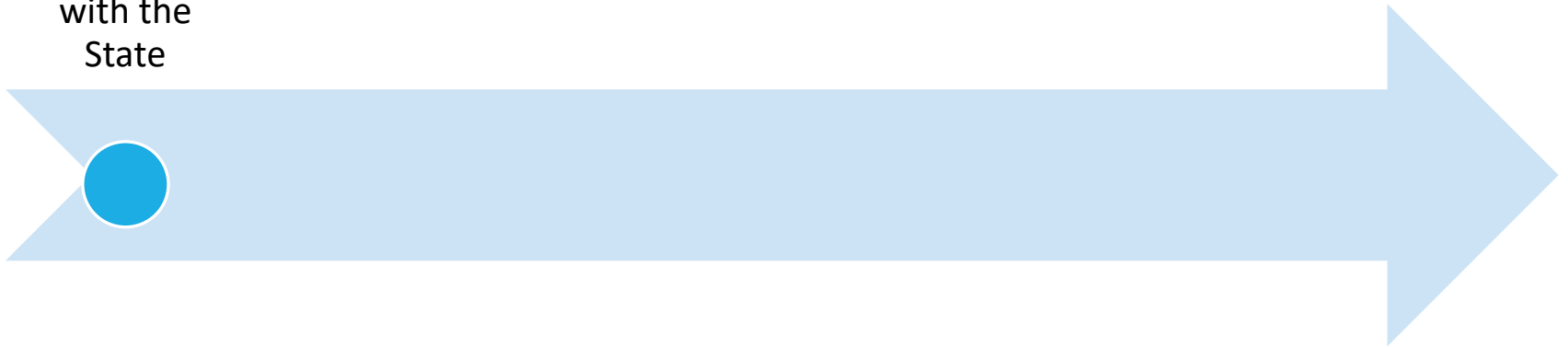


Centralized Grantee Registration Process Under GATA

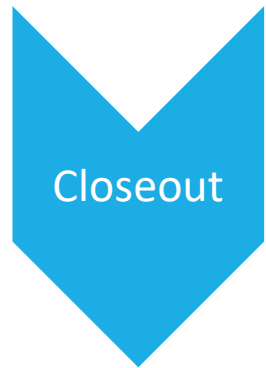

Feedback Drives GATA Enhancements

- Grantees - not-for-profits (human services and criminal justice sectors), local governments (counties and municipalities) and universities (U of I, NIU)
 - Grantees make up approximately 40% of GATA Committees
- State agencies – Chief Accountability Officer (CAO) at each agency
 - 8 Advisory Agencies (DCEO, DHS, DPH, ISBE, IDOT, DCFS, Aging and ICCB) award approximately 95% of all grants statewide
 - CAO meetings every other week
- Stakeholder groups - external auditors (working with groups of grantees), legislators, grantee advocates (GFOA, Forefront, Illinois Partners)
 - GATA listening sessions - GATU partnering with state awarding agency



GATA Revisions

- Illinois cannot change the federal rules, but we can improve how we comply with the requirements
- Implemented Illinois NOFO Notifications to promote funding
 - Based on a registry, weekly emails communicate NOFOs posted during the prior week; over 1200 subscribers
- Updating GATA website, <https://grants.illinois.gov>, for more direct access to technical assistance for all users
- Translating key GATA documents to Spanish
- Streamlined risk assessment to a single questionnaire (ICQ)
- Developed [GATA New User Guide](#) to assist organizations with the Grantee Portal

What Does Pre-qual Mean?

What Does Pre-qualification Mean?

Pre-qualification means that all of the registration steps have been met and that the status for the grantee is “Good” relative to an active SAM.gov registration, the Federal Excluded Parties List, Stop Payment List, the Secretary of State registration (if required) and the DHFS Sanctions List (also known as the Illinois Medicaid Sanctions List). **Once the pre-qualification steps are met, the grantee is in “Qualified” status.**

An organization must be in qualified status by the application review date set by the state awarding agency. Federal flexibilities can temporarily allow applications to be considered before a SAM.gov account is active, but grants cannot be awarded to entities that do not have an active SAM.gov account.

Audit Streamlining

- GATA audit threshold only includes state-issued awards – direct federal funding was removed from the calculation
- Enhanced Audit Certification Form – simplified language, requires more information regarding auditor
- Streamlined Consolidated Year-end Financial Report (CYEFR)
 - CYEFR doesn't have to tie to total financial statement expenditures
 - Simplified CSFA program expenditure reporting
- Improving user instructions for grantees and grantee auditors, ARRMS Manual



Indirect Cost Rate Election System (ICRES)

- Previously, all grantees were required to work through the CARS system
- Now grantees make indirect cost rate election in ICRES
 - Waive
 - De Minimis
 - Federal Negotiated Indirect Cost Rate Agreement (NICRA)
 - State Negotiated Rate
- Waive and De Minimis, one-time election required
- Federal NICRA, grantee uploads required documents in ICRES
- State Negotiated Rate, once grantee has an award in the CSFA, notification sent to CARS for negotiation process to begin

GMS = GATA Frameworks in AmpliFund Software



- Statewide Grant Management System (GMS) includes federal grant requirements, GATA templates and systems and standard workflow through AmpliFund software
- AmpliFund will be Illinois' system of record for grant administration for all state agencies under the Governor
- Grant making cycles dictate agency implementation timelines
 - 18 agencies are currently using AmpliFund including Aging, CDB, DCFS, DNR, EPA, ICJIA, ISP
 - Over 350 NOFOs have been published in AmpliFund to date
 - Vendor led training supports the state agencies and grantees



Improving Equitable Access to Grant Funds

- Recognize the need to make grant funding available to community-based organizations and others with limited grant experience
 - Learning curve to understand requirements, submit a competitive application and comply with post-award terms
 - GATA listening sessions and targeted stakeholder groups provide insight
- Expanding the learning management system and grant training curriculum developed by ICJIA and DHS for statewide use
- Goal: Make grant administration support and grant funds accessible to new entities so they can partner with Illinois

Title Violence Against Women Act (VAWA) - Culturally Specific

Description Congress first passed the Violence Against Women Act (VAWA) in 1994 and reauthorized the Act in 2000. With a reauthorization in 2005, Congress began a new initiative of the S.T.O.P. (Services * Training * Officers * Prosecutors) VAWA program by authorizing grants to states for programs that would improve the response of the criminal justice system to female victims of sexual assault and domestic violence. The program's objectives include: •Providing services to women who are victims of sexual assault and domestic violence. •Developing, implementing, and evaluating a plan for training police, prosecutors, judges, circuit clerks, probation officers, and service providers to promote an interdisciplinary approach to sexual assault and domestic violence. •Implementing measures that document and assess the response of criminal justice agencies in Illinois to sexual assault and domestic violence. The Act specifies that states must allocate 25 percent of the funds to law enforcement, 25 percent to prosecution, 30 percent to service providers, and 5 percent to the courts. The remaining 15 percent can be allocated at the state's discretion. VAWA was reauthorized in 2013.

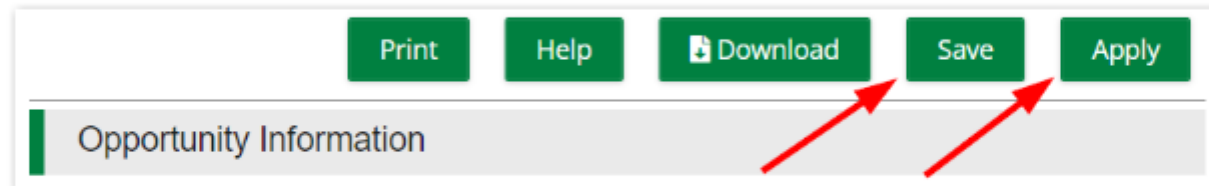

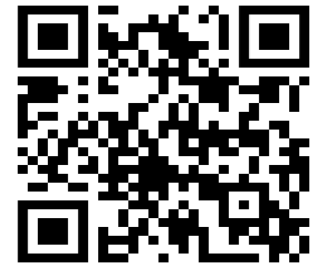
