MSI Grants



The Mission Sustainability Initiative (MSI) at Forefront is dedicated to helping nonprofits thrive by providing the resources for leaders to regularly and thoughtfully explore collaboration and partnership strategies. Grantmaking is one strategy



leveraged to achieve the MSI's intended impact: Nonprofit leaders in Illinois leveraging sustained collaboration to build robust business models, expand their organizations' impact, and preserve valuable programs that might otherwise be lost. These grants are made possible by a collective of funders that support collaboration and provide guidance and oversight to the MSI.

The first stop in exploring an MSI grant is a conversation with the MSI Director, who will confirm eligibility and fit with the MSI funding priorities and provide guidance and connections to other helpful resources.

Grant Amount & Use

- Standard MSI grants are made in the amount of \$5,000.
- In addition to grant funds, grantees receive a one-year complementary Forefront membership, an introduction to a nonprofit leader with partnership experience through Forefront's Peer Skill Share program, and ongoing access to confidential conversations and guidance from the MSI Director.
- Grants are flexible in nature, and funds may be used for any purpose that advances the exploration
 of strategic partnership development.
- Grants are available for Pre-Exploratory and Exploratory MSI Project Types (see Project Type descriptions below).

Eligibility

- The partners must be exploring a long-term/sustained administrative collaboration designed to build a more resilient business model and strengthen the applicants' effectiveness in fulfilling their missions.
- The primary applicant (and the resulting organization in the case of a merger or acquisition) must be an Illinois-based 501c3 nonprofit organization or be an Illinois-based organization that is fiscally sponsored by a 501c3 nonprofit organization. The partnering organization may be based elsewhere. For the Fall 2024 grant cycle, the primary applicant (and the resulting organization in the case of a merger or acquisition) must be based in one of the following counties: Cook, Lake, DuPage, Kane, Kendall.
- The partnering organizations must be aligned on the overarching goals of the partnership and must have board approval to explore or implement the partnership.
- The partnership project must have a goal and/or learning objective (or set of goals and/or learning objectives) that is appropriate for the project type for which funding is being requested and aligned with the overarching goals of the partnership.
- The project must be aligned with Forefront's values of diversity, inclusion, equity, and justice.
- The partners must have participated in at least one joint consultation with the MSI Director.
- The MSI will not fund short-term partnerships or program-only collaborations that do not involve a fundamental shift in the partners' business models.
- The MSI will not provide funds for ongoing programmatic, operational, or capital costs.
- Partnerships may receive multiple MSI Grants over time, but a partnership will only be considered
 for one MSI Grant per cycle. Multiple partnering organizations may not simultaneously apply for
 funds for the same partnership exploration project.

Priorities

- Priority is given to the following applicants:
 - Organizations with budgets of \$10 million or less
 - Organizations engaged in their first strategic partnership development process, or the first process under their current leadership
- Priority is given to the following partnership projects:
 - Projects where the grant will play a catalytic role in the exploration or design of a strategic partnership
 - Projects that display a high degree of innovation or creativity in their approach to collaboration and business model development
 - Projects that aim to advance racial equity

Application Process

The first step in any application is scheduling a meeting with the MSI Director, who will help to confirm eligibility and fit with the MSI funding priorities and provide guidance and connections to other helpful resources. In the case of exploratory projects, which involve more than one organization, at least one meeting with the MSI Director should include a representative from all partnering organizations.

An MSI Grant application may be submitted online or in conversation with the MSI Director. A sample of the online grant application is provided at the end of this document. Applications submitted by conversation will cover the same questions as those included in the online application. Applicants are encouraged to select whichever application method is easiest for them.

Reporting & Learning

- At the conclusion of each funded partnership project, organizations are asked to report on how MSI funds were used to advance their goals, recognizing that MSI funds will likely be combined with other funding sources to cover a portion of the project costs.
- Organizations are asked to share the outcome of their partnership project, provide an update on the status of their partnership development process and goals, and share feedback or insight about the process.
- Grant reports may be submitted online or in conversation with the MSI Director.

MSI Project Types

- **Pre-Exploratory projects** are opportunities for single organizations to explore their partnership goals and readiness.
 - Cost drivers for pre-exploratory projects typically include assessments and meeting facilitation.
 - A possible outcome of a pre-exploratory project is a Letter of Intent to begin an exploratory process.

- The core goal for pre-exploratory projects is the articulation of an organization's priorities and capacity for strategic partnership, which may or may not include specific plans for developing a partnership in the near future.
- Exploratory projects are opportunities for two or more organizations to develop a strategic
 partnership strategy, build trust between organizations, conduct due diligence, determine
 mission/vision values alignment, negotiate a Partnership Agreement or Memorandum of
 Understanding, and build a plan for partnership implementation.
 - Cost drivers for exploratory projects typically include strategic partnership consulting, accounting, and legal support (if not available pro bono), and meeting facilitation.
 Exploratory projects generally require a significant time investment from organizational leadership and board members.
 - A possible outcome of an exploratory project is a Memorandum of Understanding or Partnership Agreement.
 - The core goal for exploratory projects is all partners gaining sufficient understanding and knowledge to move forward in the way that best serves the goals of the organization, which may or may not involve the specific partnership under consideration.
- **Implementation projects** are opportunities to build the infrastructure that a partnership needs to thrive. The nature of this infrastructure will vary significantly based on the type of partnership.
 - Cost drivers for implementation projects typically include accounting, HR, IT, and other integration specialties, cultural and other integration consulting, brand development, and other costs associated with implementing specific partnership types. Exploratory projects generally require significant staff and leadership time.
 - A successful outcome of an implementation project is the completion of the partnership implementation plan as developed during the exploratory phase.
 - The core goal for implementation projects is the development of the foundation needed for a sustained and unified partnership.
 - During FY25, Implementation projects will not be eligible for MSI grants. Organizations engaging in implementation projects should contact the MSI Director to discuss additional resources.
